Workplace Pension rules mean that ALL employers have workplace pension duties which include a Declaration of Compliance to the pension regulator.

Auto-enrolment duties come into effect from your Staging Date. This means that employees must be assessed to see if they are eligible for auto-enrolment. Any employee between the age of 22

and state pension age, who earns more than £192 per week (£10,000 per annum), must be automatically enrolled into a workplace pension scheme. Any other employee can ask to join the scheme.

Employees ages 16-74 and earning less than £113 per week (£490 per month) can join the workplace pension scheme, but you won't have to pay into it. Employer contributions must be made for all other employees who are making contributions.

Employer contributions are currently 1% of gross earnings above £113 per week. From 6th April 2018 this rises to 2%, increasing to 3% by 6th April 2019.

## The Alcohol Wholesaler Registration Scheme (AWRS)

From 1st April 2017, if you buy alcohol from a UK wholesaler, you will need to check that they have registered with HMRC and have an AWRS unique reference number (URN).

If you buy alcohol from a non registered wholesaler, you may be liable to a criminal or civil penalty and your alcohol may be seized. You will be able to use an online look-up service of approved wholesalers which will be available from April 2017.



You should have put up your beer prices because of the budget increase. If you haven't, it will cost you hundreds of pounds a month.

## Introducing the New £1 Coin

The new £1 coin went into circulation on 28th March, and our existing £1 coins will be phased out after a six-month transition period.

The new coin is 12-sided with grooves on alternate sides and is made of two different metals. It has an image like a hologram that changes from a '£' symbol to the number '1' when the coin is seen from different angles. It also has very small lettering on the lower inside rim on both sides of the coin, as well as



hidden, built-in high-security features to protect it from future counterfeiting.
